# Item 6: Legislative Updates:

- Tyler Young discussed the proposed statewide budget cuts to Tourism. Lake Texoma State Park is on the list to currently be cut. Tourism is third largest industry of Oklahoma's economy, with travelers spending \$8.6 billion dollars a year in the state.
- Judi Elmore stated with President Trump's Skinny budget cut, the Heartland Flyer may be cut. She handed out map detailing the reduction of AMTRAK service in the proposed budget.

### Item 7: Marketing Update:

Tyler Young stated his trade show in Oklahoma City went very well, we are working on new vinyl for billboard, attraction brochure, newsletter template, and two RFP's for events at Convention Center.
